1. All entrants must be members of the LAKE COUNTY USBC WOMEN'S BOWLING ASSOCIATION and at least 50 years of age. If a bowler is bowling in another association, but resides within our jurisdictional boundaries of LAKE COUNTY, excluding the city of Waukegan, they will be allowed to bowl in this tournament. If a bowler does not reside in our LAKE COUNTY boundaries, that bowler must have at least an 18 game current average in a LCUSBCWBA league. ***If not a member of the Lake County Association, entrant must pay a certification fee of \$8.00.***
2. Entrants in this tournament shall use their HIGHEST USBC CERTIFIED FINAL AVERAGE from the 2016-2017 season (minimum of 21 games). If there is no final average from 2016-2017, entrants shall use their HIGHEST USBC CERTIFIED AVERAGE for 12 games or more as of March 24, 2018, in which case a league standing sheet must be provided to the tournament director. All others will bowl scratch.
3. Format for the tournament is a 9-pin no-tap with handicap. Three games will be bowled. Handicap for bowlers age 69 and under will be based on 90% of 210. Handicap for bowlers age 70 and over will be based on 100% of 210.
4. This tournament is USBC certified and all USBC rules apply with the exception of rule 319a2, 319d, and 319e.
5. Failure to use the proper average shall DISQUALIFY score if the submitted average is lower than the actual average thereby resulting in a higher handicap. Prize winnings shall be based on the submitted average if it is higher than the actual average (rule 319a-3).
6. ENTRY FEE IS \$18.00 (\$10.00 fees and expenses and \$8.00 prize fund). Prize fund will be returned 100%. One of every 5 entries will cash.
7. Please submit applications together if you have a group that you would like to bowl with, or write the names on the back of this entry form. We will do our best to accommodate all requests.
8. Reserved entries close March 23, 2018. We will accept walk-ins on March 24, 2018, with a late processing fee of \$5.00 and providing lanes are available.
